



Rules and Regulations for Participants and Instruction

Ice Driving USA LLC requires all participants to read, understand, and comply with the following rules and regulations. These guidelines are designed to ensure the safety of all participants, instructors, and team members while providing a professional and instructional ice driving experience.

General Requirements

- **Eligibility:**

Participants must hold a valid driver's license and be at least 18 years of age. No minors are allowed to participate under any circumstances.

- **Liability Waiver:**

All participants must sign a liability and damage waiver before being allowed to take the course. NO WAIVER, NO PARTICIPATION. This waiver outlines the inherent risks of ice driving, including but not limited to vehicle loss of control, collision, ice breakage, and exposure to extreme conditions.

Safety Guidelines

- **Instructor Oversight:**

Participants are only allowed in vehicles or on the course with direct supervision and instruction from Ice Driving USA LLC instructors or team members.

- **Mandatory Safety Briefing:**

All participants must attend and fully engage in the safety briefing before entering any vehicle or accessing the course. Instructions provided during the briefing must be adhered to at all times.

- **Communication:**

Two-way radios must be operational and actively monitored by all participants during course activities.

- **Seat Belts:**

All participants and team members are required to wear seat belts at all times while in vehicles.



- **Seat Belts:**

- **Incident Reporting:**

The Ice Driving USA LLC team must be notified immediately of any issues with vehicles, course conditions, or equipment.

Vehicle Rules

- **No Unauthorized Passengers:**

Guests or spectators are not permitted to ride in vehicles operated by participants. The only individuals allowed in the car are the two drivers participating in the class and the designated driving instructors.

- **Vehicle Damage Responsibility:**

Participants shall be liable for parts and OEM retail labor costs if the total repair cost is less than \$1,500. If the total repair cost exceeds \$1,500, the participant must pay an excess fee of \$1,500. This excess fee must be paid in full on the same day as the accident, using a credit card, prior to departing from the event location. This aligns with the liability agreement signed prior to participation.

- **Mechanical Issues:**

Ice Driving USA LLC will cover regular fuel, wear and tear, and mechanical issues unless the damage is caused by negligence or abuse on the participant's part.

Prohibited Activities

- **Alcohol and Substances:**

Alcohol consumption or use of any substances that impair driving is strictly prohibited before and during the event for both participants and team members.

- **No Racing or Timing:**

This event is instructional, and racing or timing of laps is not permitted under any circumstances.

- **Compliance with Instructions:**

Participants who fail to follow the instructions or direct orders of Ice Driving USA LLC team members will have their participation revoked without a refund.



Event Operations

- **Event Schedule Changes:**

The event agenda may be altered at the discretion of Ice Driving USA LLC due to factors such as weather, course conditions, participant, mechanical issues, or other unforeseen circumstances. Refunds or credits will only be considered in accordance with the official cancellation and rescheduling policy.

- **Vehicle Variations:**

The make, model, equipment, or features of vehicles may be substituted or changed at any time. This does not entitle participants to refunds or fee reductions.

Additional Regulations

- **Dress Code:**

Participants must wear appropriate clothing and footwear suitable for winter driving conditions. Open-toed shoes or high heels are not permitted.

- **Behavior and Conduct:**

Aggressive driving, reckless behavior, or any actions that endanger the safety of participants, team members, or equipment will result in immediate removal from the event without a refund.

- **Health and Fitness:**

Participants must be in adequate physical and mental condition to operate a vehicle safely. Any pre-existing conditions that may impair driving should be disclosed before the event.

- **Photography and Filming:**

Participants consent to Ice Driving USA LLC capturing photos or videos during the event for promotional purposes. Personal recording devices are allowed but must not interfere with safety or instruction. Participants acknowledge and accept the media release policy detailed in the official Photo and Video Release Form.



- **Cancellation Policy:**

Participant cancellations must follow Ice Driving USA LLC's cancellation policy, and refunds/rescheduling are subject to the terms outlined at the time of registration. No monetary refunds will be given; only account credit is provided per the cancellation policy.

- **Walking Hazards:**

Participants should be aware that walking on the ice may be slippery, and caution should be exercised when moving around the course. Proper footwear with good traction is strongly recommended to avoid accidents.
